CSPI Donor Privacy Policy

Center for Strategic Policy Innovation's (CSPI) Commitment to Our Donors

CSPI will not sell, share, or trade our donors' names or personal information with any other entity, nor send mailings to our donors on behalf of other organizations. This Privacy Policy explains how CSPI may collect, use, and disclose information we obtain through the Services. By accessing our Services, you agree to these Terms. If you do not agree to these Terms, do not access or use the Services. "Personal Information" means information that alone or when in combination with other information may be used to readily identify, contact, or locate you, such as your name, address, email address, or phone number. We do not consider Personal Information to include information that has been anonymized so that it does not allow a third party to easily identify a specific individual. Personal Information can be used to readily identify, contact, or locate you.

This policy applies to all information received by the CSPI, both online and offline, on any Platform ('Platform', includes CSPI's website and mobile applications), as well as any electronic, written, or oral communications. To the extent any donations are processed through a third-party service provider, our donors' information will only be used for purposes necessary to process the donation.

Information You Provide to Us. When you use the Sites, we or our service providers may collect information that could reasonably be used to contact you, to allow you to participate in our programs or to identify you personally, such as your name, birthday, email address, telephone number, mobile phone number, mailing address.

Information We Collect Automatically whenever you visit or interact with the Sites. We or our service providers may use a variety of technologies, that automatically or passively collect information about how you access or use the Sites ("Usage Information") to provide you a better experience on our websites. Usage Information may include your browser type, operating system, the page served, the time, and the preceding page views.

Device Identifiers. We may also automatically collect your IP address or other unique identifier ("Device Identifier") for the computer, mobile device, technology or other device (collectively, "Device") you use to access the Site. A Device Identifier is a number that is automatically assigned to your Device when you access a web site or its servers, and our computers identify your Device by its Device Identifier. We may use a Device Identifier to, among other things, administer the Service, help diagnose problems with our servers, analyze trends, track users' web page movements, help identify, and gather broad demographic information for aggregate use.

Cookies and Do Not Track. We may collect information about you or your use of the Site through cookies, tracking pixels, mobile identifiers or other technologies. We use this information to better understand, customize and improve the Site, programs and offerings as well as to manage our communications. The information we collect through cookies, tracking pixels or mobile identifiers may help us understand how visitors use and engage with the Site. If you have provided us with your Personal Information, for example, when you registered for an account or requested information from us, we may associate this Personal Information with information we have collected through cookies, tracking pixels, mobile identifiers or other technologies.

Cookies. A “cookie” is a file that websites send to a visitor’s computer or other Internet-connected device to uniquely identify the visitor’s browser or to store information or settings in the browser. Your browser may tell you how to be notified when you receive certain types of cookies or how to restrict or disable certain types of cookies. Please note, however, that without cookies you may not be able to use all of the features of the Site. When you use the Site, neither we nor any third parties collect Personal Information about your online activities, over time or across third party websites.
